2. The Candidates working with Government Departments/ entities or Semi-Government entities may apply through proper channel along with requisite **No Objection Certificate** (NOC) under the law.
3. Candidates are required to apply online on Government portal (<https://jobs.punjab.gov.pk/>) and a hard copy of the online submitted application along with attested copies of all relevant documents shall be submitted to the concerned offices (Addresses given above), before the last date of submission, failing which, online application shall be rejected.
4. The name of the post for which the candidate is applying shall be mentioned clearly both on the online application and on the envelope containing hard copies of submitted application.
5. The candidates interested in more than one post in different Forest Divisions shall have to submit applications (online & attested hard copies) for each post separately.
6. Applicant applying against the women or minority quota shall clearly indicate it in the relevant column on the designated website portal and shall also specifically mention on the outer envelope included attested documents as required for proper evaluation of their applications.
7. Incomplete applications / submitted after due date shall be rejected without informing the applicants.
8. Only shortlisted candidates shall be invited for endurance / physical test through SMS / e-mail/ Call.
9. Any grievance against scrutiny of documents / short listing by office of the concerned Deputy Conservator of Forests / Appointing Authority may be submitted to office of the concerned Conservator of Forests within **three (03)** days after shortlisting notification.
10. The date of the physical / endurance test and the interview will be intimated to the shortlisted applicants through SMS / e-mail/ Call.
11. The candidates who qualify physical test will be called for an interview wherein they shall have to bring their original educational documents along with NOC (where applicable), domicile, CNIC, two (02) passport size recent photographs.
12. The recruitment shall be **Forest Division** specific and strictly in accordance with the standing Law/Rules/Policy/ Instructions of the Government of the Punjab.
13. The selected candidates shall have to undergo such training as prescribed under the Rules / Policy of the Department.
14. No T.A. / D.A. will be admissible for test / interviews.
15. The Competent Authority may cancel the recruitment at any time without any prior notice.
16. Any grievance / complaint against the physical test or interview may be submitted to **Grievance Redressal Cell** constituted at Administrative Department i.e. **Forestry and Wildlife Department at 108 Ravi Road Lahore**, within three (03) days, whose decision shall be final.
17. **Last date for submission of applications is 04-03-2026.**
